Analysis

[NAME] is at the top of many organizations' prospect lists and with good reason. This year, [FUND]'s performance has been less than stellar, and though it has little to do with his capacity, we hear that getting his attention at present will be somewhat challenging until market conditions improve. His high profile makes it unlikely for [CLIENT] to attract him to its Board, given the size of the organization. However, he would make an excellent Gala honoree or major gift prospect, in the \$100K to \$150K range.
